

PRIVACY STATEMENT

HUMBLE BV, located at Pythagoraslaan 101 3584BB Utrecht, is responsible for the processing of personal data as described in this privacy statement.

1. PERSONAL DATA THAT ARE PROCESSED

HUMBLE BV may process personal data about you, because you use the services of Humble, and/or because you supply these to HUMBLE yourself when completing a contact form on the website.

HUMBLE BV may process the following personal data:

- Your first and last name;
- Your phone number;
- Your email address;
- Your IP address;
- Other personal data that you actively provide, for example by filling in a contact form on this website, in correspondence and by telephone;
- Information about your activities on our website;
- Internet browser and device type.

2. FOR WHAT PURPOSE WILL THE DATA BE PROCESSED?

- HUMBLE processes your personal data to be able to contact you by phone if you request this, and/or to contact you by e-mail if you cannot be reached by phone;
- HUMBLE may use your personal data in the context of the execution of an agreement entered into with you;
- Sign-ups for events;
- Sending of newsletters;
- Handling questions and complaints;
- Conducting a customer satisfaction survey.

3. HOW LONG HUMBLE BV KEEPS YOUR INFORMATION

We do not keep personal data of visitors any longer than necessary for the purposes for which they were obtained, unless we are legally obliged to keep data for a longer period.

4. SHARING OF PERSONAL DATA WITH THIRD PARTIES

HUMBLE BV will only provide your personal data to third parties if this is necessary for the execution of an agreement with you, or to comply with a legal obligation. We may share your personal data with:

- Clients or cooperation partners or customers of HUMBLE;
- Service providers engaged to perform services on behalf of HUMBLE BV;
- Third parties, including but not limited to regulators, tax authorities or other agencies to comply with legal obligations.

With third parties who process personal data on our behalf, we conclude a processing agreement to ensure an adequate level of security and confidentiality of the personal data of our visitors. HUMBLE BV remains responsible for these processes.

5. COOKIES, OR SIMILAR TECHNIQUES, THAT WE USE

On the website of HUMBLE BV general visit data is kept, HUMBLE BV uses functional, analytical and tracking cookies for the website. This data is made anonymous as much as possible and is not provided to third parties. You have the right to access, correct or delete your personal data.

Under the General Data Protection Regulation, you have several rights with respect to your personal data to ensure your privacy:

- Right of inspection;
- Right of improvement/completion;
- Right to erasure;
- Right to restrict processing;
- Right to transferability;
- Right to object to processing.

8. SECURE

HUMBLE BV takes the protection of your data seriously and takes appropriate organizational technical measures to prevent abuse, loss, unauthorized access, unwanted disclosure and unauthorized changes.
